GMMWater's Board approve the schedule of tariffs for the forthcoming financial year in June each year. Where the conduct of these activities are considered to be part of a prescribed service under the Victorian Water Industry Regulatory Order (WIRO) these charges are the subject of approval by the Essential Services Commission. Where these activities are not part of a prescribed service the charges are based on the cost of providing the service. Pension and Concession Card Rebate

Concession entitlements include all eligible pensions and health care card holders. Cardholders already registered with GMMWater will automatically receive concessions on each account.

Water and Sewerage Rebate Scheme

The State Government offers a rebate on fixed water and wastewater service charges for eligible not-for-profit organisations. Further details regarding eligibility may be obtained by contacting GMMWater on the number below.

Water Resources

The fixed and variable fees and charges on this schedule relate to water sourced from;

- Groundwater:
 - Groundwater catchments: West Wimmera catchment, Wimmera-Mallee catchment, Avoca catchment
- Surface Water:
 - River basins: Wimmera-Avon basin, Avoca basin, Glenelg basin
- GMMWater also supplier water sources from the Murray and Goulburn basins via its pipeline networks

Billing

Urban and Rural domestic and stock pipeline customer billing will be in quarterly instalments.

GMMWater may bill commercial or other customers with high water usage monthly.

Other customer groups, including diversion customers and irrigation customers, will be billed at least annually.

Description of Fees and Charges

Capacity Charges~	Represents the share of the pipeline infrastructure that a rural customer can potentially utilise within the system and is based on the standard water allowance.
Volumetric Charges~	Recovers a portion of the costs of operating, maintaining and renewing the water network, charged on a consumption basis as indicated.
Usage Charge~	The usage charge is per kL up to 100% of the total water allowance. All consumption above 100% will attract the excess usage charge.
Meter Charge~	The meter charge is used to recover the cost of meter reading, repairs and replacement and billing and is based on a standard 20mm meter at the property boundary.
Area Charge~	Recovers a portion of the costs of operating, maintaining and renewing the Walpeup West Bore network and is payable by customers within the Walpeup West Bore district.
Licence Fee~	Payable in relation to the licence to take water from groundwater or other waterway sources.
Volumetric Charges (Groundwater)~	Licence fees for Groundwater planning and management activities based on licenced volume. Licence fees cover the cost of licencing and metering groundwater and diversion activities.
kL	Kilolitre (1,000 litres).

ML	Megalitre (1,000,000 litres).
Unregulated Waterways	Recovers the cost of streamflow monitoring and metering
Service Availability Charge (SAC)~	Recovers a portion of the costs of operating, maintaining and renewing the infrastructure required to ensure availability of service to your property. This charge is based on a 20mm meter and applies to each connection.
New Customer Contributions~	Recovers that costs associated with augmenting GWMWater's network to ensure availability to additional properties.
Pressure Sewer Unit Charge~	Recovers the cost of materials required for a pressure sewer unit connection.
Plan Checking & Supervision Fee~	Recovers the administrative costs of ensuring new connections comply with the minimum requirements and standard suitable to connect to GWMWater's network.
Application Fees~	Recovers the administrative costs associated with reviewing, assessing, determining and processing a request for service.
Trade Waste and Disposal Fees~	Covers the costs associated with additional treatment of discharges required to meet wastewater standards. The volume and characteristics of the waste being discharge, and the risks associated to GWMWater's sewer system of the discharge necessitate how waste customers will be categorised.
Primary Meter~	A meter that services a household and includes a primary allowance of 730kL.
Standard Meter~	A meter that is not a Primary Meter
Recreation contribution charge~	Recovers the costs associated with supplying discounted water to eligible sporting clubs, services clubs, schools and nominated recreation lakes and weirs across the GWMWater region.
Standpipe/Metered Hydrant Charges~	Recovers a portion of the costs of operating, maintaining and renewing Standpipes and Hydrants throughout the GWMWater's region.
Connection charges~	Recovers the material, administrative and operational costs associated with connection of a new meter to an available property within the existing GWMWater's network.
Special Meter Reading~	Recovers the costs associate with determining a meter reading at a point in time outside the usual meter reading program by customer request.
Meter Testing Fee	Recovers the costs associated with obtaining an independent testing of a meter
Transfer of Entitlement	Recovers the administrative costs associated with reviewing, assessing, and processing a Water Entitlement, Groundwater Licence or Surface Water Licence Transfer.
Document Preparation, Copying and Printing	Covers the administrative costs of preparing, copying and printing documentation
~	Denotes a charges approved by the Essential Services Commission
