4. Conditions for Subdivision of Water Allowances

- a. Water allowances will only be allocated to land that has a meter connected to the pipeline system, or for which an application to connect to pipeline has been lodged.
- b. Water allowances will be apportioned between the separate metered entities of a subdivision according to the instructions provided by the subdivider in this application.
- c. For subdivided entities with standard meters only a standard allowance of at least 100 kL must be allocated.
- d. The sharing of meters by land parcels requiring water supply created by the subdivision of water allowances is not permitted. Existing meters will be allocated to the adjacent land parcel at the time of subdivision, or for primary/house meters the land parcel with the house.
- e. The 730 kL primary allowance will remain with the primary (house) meter.

This form must be accompanied with the payment of the \$192.10 application fee. Payment is to be made before we can process your application.
